7. **Seller represents that at the time of Delivery these RECs satisfy the requirements set forth in Section 3.2 of the Agreement, and that each REC provides all environmental attributes of one MWh of generation from resources of the type and location as checked in "Type of REC" and "Location of REC", respectively in this Product Order and that the renewable resource and associated renewable energy credit meets the following requirements specified in the Illinois Power Agency Act (20 ILCS 3855/1-10):**

"Renewable energy resources" includes energy and its associated renewable energy credit or renewable energy credits from wind, solar thermal energy, photovoltaic cells and panels,

biodiesel, anaerobic digestion, crops and untreated and unadulterated organic waste biomass, tree waste, hydropower that does not involve new construction or significant expansion of hydropower dams, and other alternative sources of environmentally preferable energy. For purposes of this Act, landfill gas produced in the State is considered a renewable energy resource. "Renewable energy resources" does not include the incineration or burning of tires, garbage, general household, institutional, and commercial waste, industrial lunchroom or office waste, landscape waste other than tree waste, railroad crossties, utility poles, and construction or demolition debris, other than untreated and unadulterated waste wood.

Additionally, if a REC is of the Type “Other Environmentally Preferable REC”, the Seller represents that the REC is from a Renewable Energy Source identified for the Product, that the Renewable Energy Source has been presented by the Seller during the REC RFP and that the Illinois Power Agency has agreed any REC from the Renewable Energy Source is eligible for the Applicable Program.
